International experts will referee chapters submitted by conference participants after the conference.

If you are asked to review chapters, please do so in a timely and deep manner – at least 1 page. This is critical for producing a high quality book on time.

These chapters are to be received by 15th September 2015 for chapter arising from regular papers and 15th November for plenary papers presented at the conference. Usually there are revisions to do. If you need assistance with English editing, please contact Gloria as soon as practicable to arrange.

Instructions for authors will be uploaded to the ICTMA17 website shortly. [Action: GS & GW]

Please follow these carefully so as to reduce the work of editors and help streamline the book production. All chapters must be original work and not submitted for consideration for publishing elsewhere. Chapters must address applications and modelling and be embedded in literature. The book is limited in size to about the size of the current book in the ICTMA series. This will mean the number of chapters you can author is restricted. All proposed chapters are not necessarily published. [Please see the power point on the ICTMA website from the Plenary presentation on Monday – Writing for Books in the ICTMA Series for further detail of the process.]

5. ICTMA18

6. ICTMA19 Expressions of Interest:

Expressions of Interest for ICTMA19 were opened on July 6. Details are on the website. Informal interest has been shown from China, Japan, Norway, Portugal, USA. Germany was also interested in hosting it again in the future. [Action: GS to follow up.]

Due to difficulties in China Jinxing Xie has closed the website in China and this was transferred to Australia temporarily to the old ICTMA15 website (www.ictma15.edu.au).
